



## City of Carson COVID-19 Update

Friday, July 17, 2020

The coronavirus outbreak began in Wuhan, China, and has since spread across the globe impacting many countries including the United States. The first case of COVID-19 in the United States was reported on January 14, according to the Centers for Disease Control and Prevention (CDC).

To help keep the community informed, the City of Carson is providing COVID-19 news updates related to health and safety tips, and informational links to meet the needs of the community and protect public health. To slow the spread of COVID-19, public health officials urge residents to practice social distancing, wash their hands regularly, wear a face covering and stay home as much as possible and avoid the “Three C’s”: Crowded places, Confined Spaces and Close Contact with others not in your household.

- **A COVID-19 Test Was Performed on Each City of Carson Employees** on Thursday, July 16, to ensure the health, safety, and well-being of staff and visitors to City Hall. Employees previously telecommuting have be instructed to do so once again minimizing staff physically reporting to work. More barriers have now been installed and additional measures are being taken to ensure the safety of all.

On Thursday, June 9, City Hall closed at 3:00 p.m. at the direction of City Manager Sharon Landers after a third employee reported having tested positive for coronavirus. The entire facility was treated with antibacterial disinfectant by a professional service as a precaution to all over the 3-day regularly scheduled closure of City Hall over the weekend. Some employees did not return to work after also testing positive while a few more were instructed to quarantine after contact tracing was completed. It is believed that most cases of coronavirus contraction was outside of the workplace.

City Hall had been closed to the public for about 3 months with minimal staff physically reported to work, some staff telecommuting, while the rest were on COVID-19 leave due to social distancing measures taken by management. After the Governor’s order allowing businesses to re-open, City Hall re-opened its doors to the public on June 29 with almost full staff physically reporting to work and all City facilities. Rules, regulations and precautionary measures were set in place for both visitors and employees throughout City Hall, while instructional memos and videos that included new guidelines, protocols and hygiene etiquette were also disseminated to all employees as well, to ensure the safety and well-being of all employees and visitors.

Please continue to follow the recommendations of public health experts to avoid the spread of COVID-19 by washing your hands often; clean and disinfect surfaces on a regular basis; stay a safe distance from one another; stay home if you are ill; avoid others who are who are ill; cover coughs and sneezes; wear face masks if you are ill. If you are experiencing high fever, along with dry cough and fatigue, call your health provider so they can provide you with professional advice and recommendations. Those with underlying health conditions, the elderly and those who are pregnant should consider calling sooner, as soon as feeling ill.
