





The Women's Issues Commission seeks City Council approval to conduct an informational symposium on Prevention and Education: Teen and Domestic Violence/Child Abuse and Diabetes/Heart Disease and Stroke on Saturday, October 16, 2010, from 10:00 a.m. until 2:00 p.m. at the Congresswoman Juanita Millender-McDonald Community Center.
