## I. SUMMARY

On January 18, 2011, Mayor Dear continued this item to February 1, 2011.

On December 21, 2010, Mayor Dear continued the balance of his appointments to the next regular meeting.

On December 21, 2010, Mayor Dear appointed Richard Vaughn as the At-Large Member to the Mobilehome Park Rental Review Board, thereby, creating the At-Large Member (Alternate) vacancy on the Mobilehome Park Rental Review Board.

On December 27, 2010, City Clerk Kawagoe received an email from Ken Freschauf wherein he resigned from the Utility Users' Tax Citizens Oversight Committee, thereby, creating a vacancy on the Utility Users' Tax Citizens Oversight Committee.

All posting requirements have been satisfied to fill the vacancy created on the Mobilehome Park Rental Review Board and the Utility Users' Tax Citizens Oversight Committee (Exhibit Nos. 2, 3, 4, and 5).

**IV. BACKGROUND**

Previous to the adoption of Ordinance No. 04-1325, the Mayor and Members of the City Council each had one uncontested appointment to each Commission. The remaining vacancies of each commission were filled by the Mayor with ratification by the City Council.

With the adoption of Ordinance No. 04-1325 on November 16, 2004, the previous method of appointments is no longer in place. Ordinance No. 04-1325 provides in part that the City Council of the city of Carson has reviewed the method by which members of city commissions and boards are appointed under current provisions of the Carson Municipal Code in light of the requirements under State law for general law cities with a directly elected mayor, and found in Government Code Section 40605.

On December 21, 2004, Ordinance No. 04-1330 was adopted and amended the Carson Municipal Code for Sections 2701, 2736, 2751, 2762, 2796.2, 2798.2, 2799.2, 4702, 27100.2, 27101.2, 27102.2 27103.2, 27104.2, 27104.2 [SIC] (Codified as 27106.2) and 27105.2, regarding the number of votes required to make an appointment to, or effect a removal from, city commissions and boards. The ordinance clarifies that appointment to or removal from city commissions and boards shall be by the Mayor with the approval of a majority of the entire City Council present, including the Mayor. Furthermore, appointments to fill existing vacancies shall be made by the Mayor with the approval of a majority of the entire City Council present, including the Mayor.

On May 5, 2009, this report was on the agenda at the request of Mayor Dear to consider and appoint new or reappoint commissioners and board members in accordance with the Carson Municipal Code. These provisions are pursuant to the requirements of Ordinance 04-1325, "An Ordinance of the City Council of the City of Carson, California, Amending the Carson Municipal Code, at Sections 2701, 2736, 2751, 2762, 2796.2, 2798.2, 2799.2, 4702, 27100.2, 27101.2, 27102.2 27103.2, 27104.2, 27104.2 [SIC] (Codified as 27106.2) and 27105.2, Regarding the Appointment and Removal of Members of City Commissions and Boards," which was adopted on November 16, 2004. The new terms expire on March 31, 2011.

The current terms of said appointees expired on March 31, 2009 with the exception of Relocation Appeals Board Members Felix Azur, Sr. and Athos Monteclaro (terms expire 3/31/10). The terms of the Human Relations Youth Commissioners expired on 4/30/09 and the new terms will expire on 4/30/10. Also, terms of the Youth Commissioners expired on June 30, 2009 and the new terms will expire on June 30, 2010. However, the Carson Municipal Code provides in part that each Commission member shall continue to serve until a successor has been appointed by the Mayor with the approval of a majority of the entire City Council present, including the Mayor, and has qualified unless the City Council declares the position to be vacant.

All commissioners and board members were invited to submit a Commission/Board Appointment Application for consideration by Mayor Dear.

V. FISCAL IMPACT

Funds for commission member compensation are included in the respective work group accounts in the adopted FY 2010/11 budget.

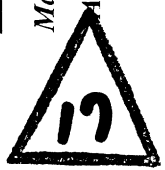



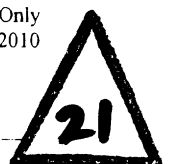
