### **I. SUMMARY**

The Treasurer's Reports before you provide detail of the cash and investments on hand for the period of September 1 through November 30, 2011.

Submission of normal monthly reports was delayed as new portfolio tracking software was being implemented by the Treasurer's Office. That process is not concluded pending the necessity of software changes by the vendor and, therefore previous report format is presented herein to prevent further delay. Normal monthly reports will resume from this point forward.

### **IV. BACKGROUND**

Pursuant to Government Code Section 53646 (b) (1) the most recent version having been amended in 2004 which provides for the optional submission of a quarterly investment report, submitted herewith are the monthly Treasurer's Reports for the period of September through November 2011 which detail the cash and investment balances for the respective periods.

For the period ending September 30, 2011, the investment balance of all City funds is \$34,933,928.00 and the cash balance is \$4,778,014.52 for a total of \$39,711,942.52. The average rate of return for those funds is 1.19% with an average maturity of 272 days. For all Redevelopment Agency funds for the same period the investment balance is \$127,834,190.83 and the cash balance is \$1,090,315.85 for a total of \$128,924,506.68. The average rate of return for those funds is .91% with an average maturity of 324 days.

For the period ending October 31, 2011, the investment balance of all City funds is \$27,939,104.89 and the cash balance is \$1,583,696.76 for a total of \$29,522,801.65. The average rate of return for those funds is 1.31% with an

average maturity of 285 days. For all Redevelopment Agency funds for the same period the investment balance is \$120,385,437.83 and the cash balance is \$1,155,870.48 for a total of \$121,541,308.31. The average rate of return for those funds is .86% with an average maturity of 151 days.

For the period ending November 30, 2011, the investment balance of all City funds is \$25,439,786.58 and the cash balance is \$3,180,707.32 for a total of \$28,620,493.90. The average rate of return for those funds is 1.40% with an average maturity of 286 days. For all Redevelopment Agency funds for the same period the investment balance is \$125,513,137.91 and the cash balance is \$450,582.82 for a total of \$125,963,720.73. The average rate of return for those funds is .88% with an average maturity of 140 days.

Market valuation was obtained utilizing our third party custodian, Bank of New York and the State of California for funds held in the Local Agency Investment Fund. In accordance with Government Code Section 53646 (b) (3) and based upon approved budget expenditures, sufficient funds exist to meet the expenditure requirements for a minimum of the next six months.
