I. SUMMARY

The Carson Housing Authority (Authority) as the successor housing entity to the former Carson Redevelopment Agency is responsible for using the Low and Moderate Income Housing Asset Fund (LMIHAF) in a manner consistent with housing bond convenants.

This report serves as notice to the Carson Successor Agency (Agency) of the Authority's intent to use LMIHAF for housing related projects in accordance with the associated tax allocation housing bond covenants.

IV. <u>BACKGROUND</u>

Pursuant to AB 1484, the Authority must provide notice to the Agency of its proposed designated use of its housing asset funds. The notice must be made 20 days before the deadline for submission of the Recognized Obligation Payment Schedule (ROPS) to the Oversight Board.

In accordance with AB 1484, this serves as the Authority's notice to the Agency of its planned use of LMIHAF for housing related projects pursuant to the terms of the tax allocation housing bond fund covenants and applicable laws. The approximate amount of funds to be used for housing-related projects during the ROPS 14-15B reporting cycle is \$6.5 million. These funds will be reported on the ROPS as "Housing Related Projects." The ROPS will be submitted to the
