Project Description

The Carson Street Master Plan Implementation Project consists of streetscape improvements of the Carson Street Corridor, a 1.75 mile stretch of roadway between the I-110 and I-405 freeways. Improvements include installation of a recycled water line, extensive colorful, drought-tolerant landscaping in parkways and medians, street furniture (benches, bike racks, and pedestrian lights), public art, entry



monuments, traffic signal modifications, reconfiguration of turn lanes, reconstruction of driveways for ADA compliance, and replacement of median street lights with LED lights. The entrance to City Hall at Carson and Avalon is also being refurbished including the construction of an ADA compliant ramp along with hardscape and landscape improvements.

Project Status

Recycled Water (RW) Line Installation: Negotiations remain ongoing between the City of Carson and West Basin Municipal Water District regarding funding of the recycled water line. In the interim, the line has been energized with a temporary potable water service in coordination with CalWater.

City Hall Improvements: Shop drawings for the Founders' Fountain plaques and paver etchings are pending a revised submittal from the Contractor, with installation anticipated to commence shortly final approvals.

Streetscape Improvements: Striping and pavement markings are completed between Grace and Figueroa Ave. Temporary delineation has been removed from the same limits. Hardscape improvements are completed between Grace St. and Figueroa along with tree and shrub planting within the same limits and north side Carson St. planters.





Tasks for the Next 30 Days

City Hall Improvements

Finalize/approve shop drawings for Founders' Fountain paver etchings and plaques.

Finalize change order pricing for modified door design and install wireless door actuator.

Refinish/paint existing stucco walls.

Install recessed uplighting for palm tree planters.

Place underslab and architectural pavers below the stairs.

Refinish handrails.

Complete drain line reconfiguration and construct sump pit/pump.

Procure and install fountain planter wall pin letters.

Streetscape Improvements

Complete landscaping adjacent to palms at South Side of Carson St., east of Avalon Blvd.

Continue to plant trees and shrubs on both sides of Carson St. and medians, east of Avalon Blvd.

Complete placement of direction signs and foundations throughout the Project limits.

Continue electrical conduit placement on Carson St., east of Avalon Blvd.

Continue Irrigation conduit placement on Carson St., east of Avalon Blvd.

Complete sidewalk placement on the north side Carson St., from Avalon Blvd. to I-405.

Overall project punch list items and site cleanup.





Critical Issues

Redesign of the proposed fencing within the LA County Department of Water and Power right of way due to unforeseen conditions.

Coordinate with West Basin Municipal Water District regarding funding of the recycled water mainline.

Coordinate with ongoing adjacent construction projects.

Coordination with LA County Department of Public Health regarding installation and proper identification of both recycled water and domestic irrigation systems.

Redesign of the proposed fencing within the LA County Department of Water and Power right of way due to unforeseen conditions.

Site/Security Safety Issues

No issues to report.

Executed Change Order

Contract Change Order #7 is currently being drafted by the Construction Management Team for signature/processing in early July. This change order will include reconciliation of recycled water line final quantities, additional no U-turn signs, expanded demolition/excavation scope to remove intrusive tree roots, subsurface slag removal/disposal, remediation of unforeseen groundwater, adjustments of unidentified curb drain lines, relocation of proposed palm trees to a new decomposed granite strip at the Community Center, and modifications to the crosswalk scope.

Project Completed Tasks for June

City Hall Improvements

Demolished and replaced curb and gutter on Carson St. and Avalon Blvd. within the City Hall plaza limits.

Completed required excavation, grading and subgrade preparation before pouring sidewalk on Carson St. and Avalon Blvd. within the City Hall plaza limits.

Constructed ADA curb ramp at the southwest corner of City Hall.

Placed curb drains and conduit for City Hall sump pump.

Streetscape Improvements

Installed directional sign foundations on Carson St. throughout project limits.

Placed traffic striping on Carson St. between Figueroa St. and Grace Ave.

Completed Ralph's intersection traffic signal turn-on.

Began installation of traffic signs on Carson St. between Figueroa St. and Grace Ave.

Began installation of seating node wall lanterns on Carson St. throughout project limits.

Planted palm trees on both sides of Carson St., east of Avalon Blvd.

Continued installation of transit shelters and street furniture.

Continued installation of subsurface electrical and irrigation improvements on Carson St. between Avalon Blvd. and I-405.

Modified the irrigation system adjacent to the VEO development at Via Verde to disconnect from the private property water source and connect to the City's new irrigation system.

Completed placement of conduit for fiber optic system at Carson St. and Avalon Blvd. intersection.

Continued placement of traffic signal detector loops throughout project limits

Placed small sections of sidewalk repair throughout project area.

Continued placement of planting soil in medians and bump out planter areas

Continued planting trees and shrubs on Carson St. and medians.

Continued slot paving at medians throughout the Project limits.

Continued pot hole repairs throughout project limits.

Removed and replaced Portland Cement Concrete sidewalk on eastbound Carson St., east of Avalon Blvd .

Raised valve and manhole covers to grade on Carson St. between Figueroa St. and Grace Ave.

Began installation of uplights for palm trees on westbound Carson St. fronting the Community Center lawn.





Project Schedule Update

A revised schedule for project completion has been received from the Contractor and is currently pending City review.

Project Look-Ahead

Completion of punch list items and touch up work is ongoing on Carson St between Figueroa St and Grace Ave. Irrigation, landscaping and sidewalk replacement on the north side of Carson St between Avalon Blvd and I-405 is expected be completed in July, with the roadway grind and rubberized asphalt overlay of this phase anticipated for August. It is anticipated that remaining irrigation within the Avalon Blvd. medians will be completed in July, with landscaping extending into August.

Remaining improvements at the City Hall plaza ongoing and expected for substantial completion in early August.
