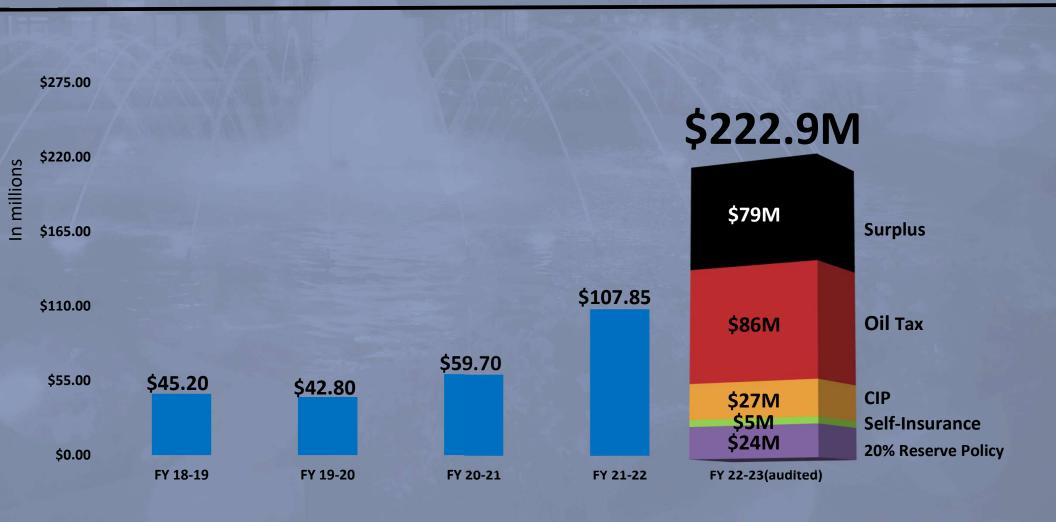

GENERAL FUND BALANCE = \$222.9M

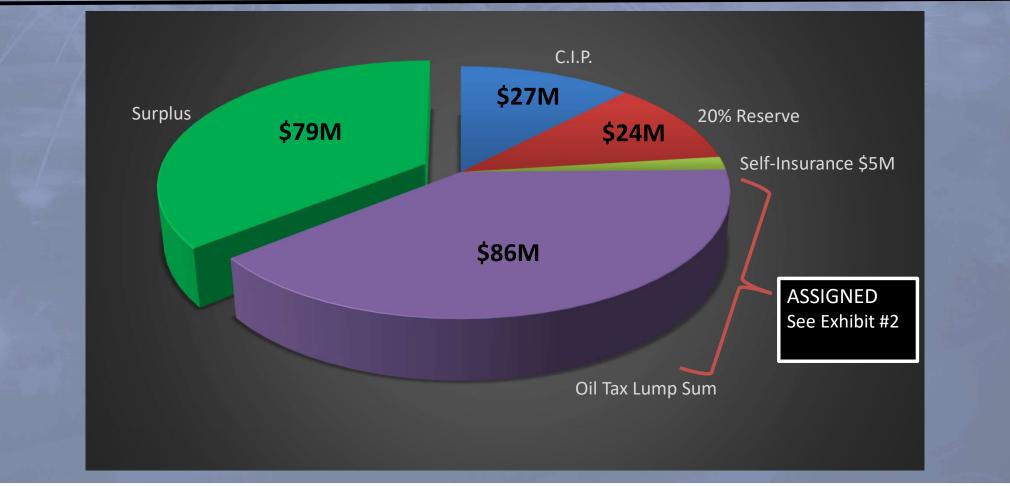

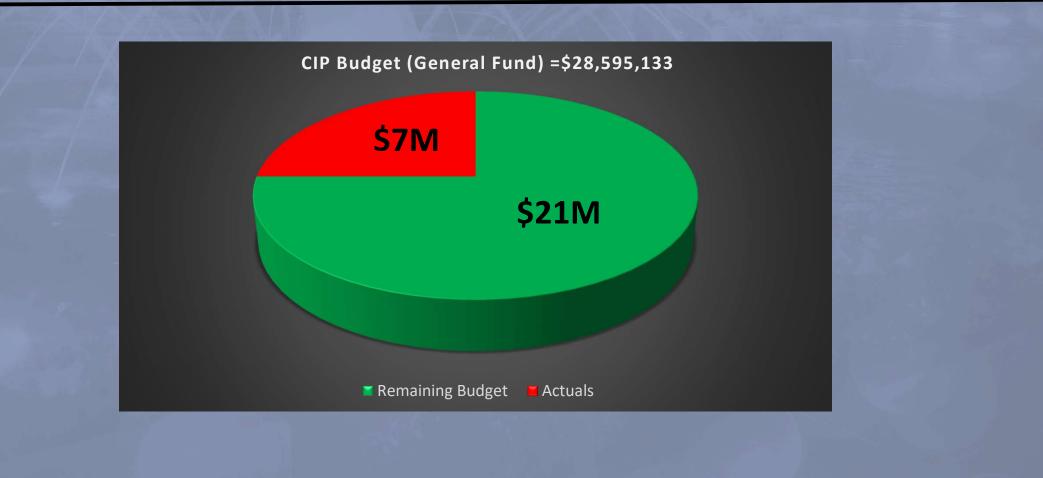

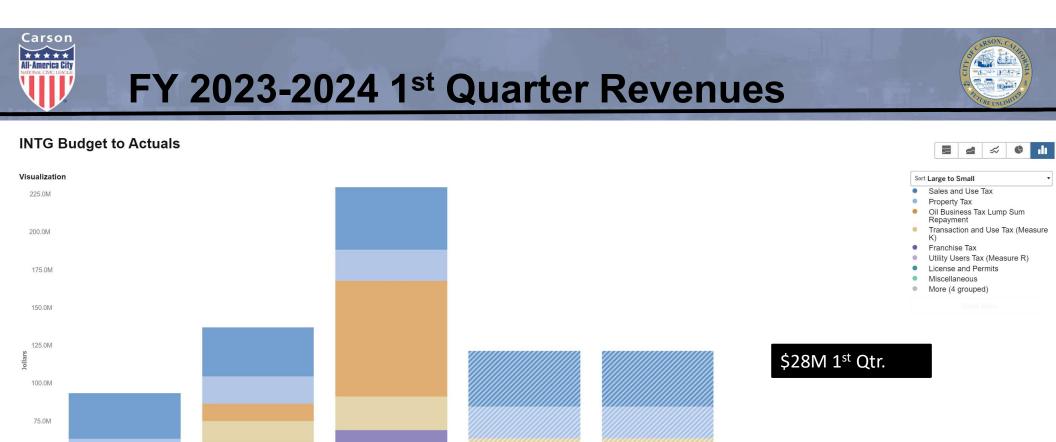

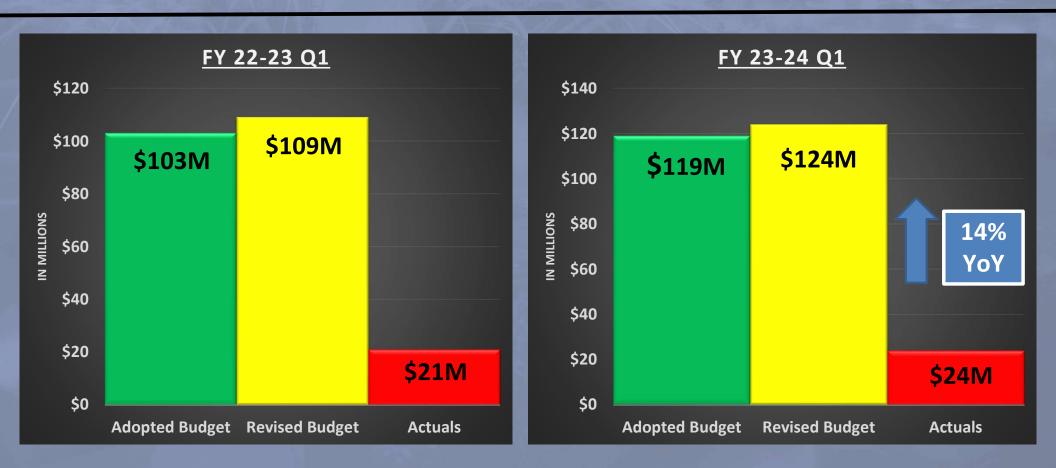

FY 22-23 First Quarter vs. FY 23-24 First Quarter





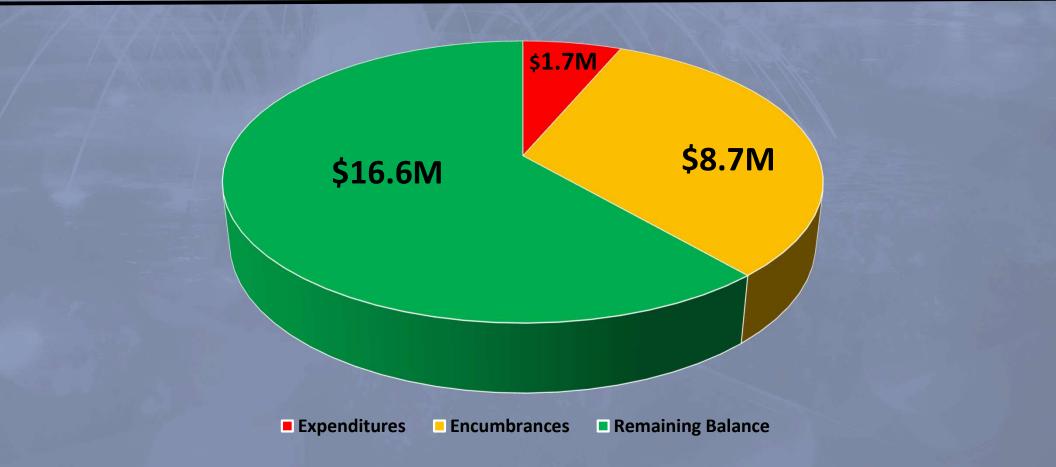
