VI. NEW BUSINESS

a. Façade Improvement Program

Director of Community Development Saied Naaseh reported Council would like to start a Façade Improvement Program. The current program, funded through the Community Development Block Grant (CDBG), has limited areas for which the money can be used. The CDBG program also has a lot of strings attached because it is federally funded. The new program will be Citywide and target bigger shopping centers to help revitalize them instead of single buildings. When the owner is remodeling the exterior of the shopping, the City would set aside some amount of money to assist the owner.

Assistant City Manager of Economic Development John Raymond reported he has worked on façade programs in several other cities and they generally work on a reimbursement basis to the property owner. There is façade improvement grant agreement in the beginning where the City will reimburse up to 25% to 50% of the cost of the facade. The owner has to do the entire improvement and then submit a detailed invoice with the costs.

Commissioners asked questions pertaining to potential seed money and a streamlined permit process.

Carson Chamber President Barry Waite stated the Chamber would like to assist with the program.

Discussion ensued.

VII. UNFINISHED BUSINESS

a. Small Business Grant Funds

Assistant City Manager of Economic Development John Raymond reported staff sent questions to the Commissioners for feedback. The same questions will be put in a staff report for the Council at the May 17, 2022 meeting. Some of the questions are the size of the grants, requirements for receiving the grants, and financial status. The loan program was not as impactful in terms of the economy of the City, so staff is trying to be more thoughtful and not plunge into another program. Staff is trying to come up with a framework that helps the Council walk through the decision-making to provide some guidance.

Director of Community Development Saied Naaseh stated it is difficult to determine if a business is growing or failing. The businesses should have to demonstrate how they will use the money.

Discussion ensued.

b. Major Events Task Force Update

Vice-Chairperson Wallace reported the taskforce discussed combining some of the critical items on the master calendars from the surrounding cities to determine how these items will impact each other. The big push is to really think about how to showcase Carson and how having a website to serve as a platform for information.
