I. CALL TO ORDER Chairperson Aldridge called the meeting to order at 8:03 a.m.

Vice-Chairperson Wallace moved to approve the May 5, 2022, regular minutes, seconded by Commissioner Kelley and unanimously carried.

VI. NEW BUSINESS

a. Industrial C.U.P

Director of Community Development Saied Naaseh gave a presentation on the current process for approving warehouse and logistics facilities. The Urgency Ordinance (No. 22-2223U) will

give the City more control and add a CEQA review. The presentation also included comments from Watson Land, Prologis, and the Carson Chamber of Commerce.

Commissioners asked questions regarding the timing of the ordinance, if the current issues be resolved during the general plan process, will it add time to the already lengthy process or opening a business, and if existing buildings will be roped into this process?

Discussion ensued.

VII. UNFINISHED BUSINESS

a. Small Business Grant Funds

Assistant City Manager of Economic Development John Raymond reported staff is finishing up the guidelines of the new grant program Council created as part of the ARPA funds. The grants will be up to \$25,000 based on several different criteria. Participants of the loan program will not be eligible for the grant program.

Discussion ensued.

b. Small Business Loan Program

Assistant City Manager of Economic Development John Raymond reported the City recreated a Small Business Loan Program. Thirty-five businesses took out loans totaling \$530K with a sixmonth grace period for repayment. In May 2022, the Council voted to forgive all of the loans. As part of the forgiveness, a refund of loan payments for businesses may have been made during that time. The ARPA funds are going to be used to be able to do this.

c. Façade Improvement Program

Assistant City Manager John Raymond reported the current program has historically funded by the CDBG program, with only certain areas of the community with low-income census tracks were eligible. The new program will be citywide no matter what census tract the business is in. Each business can receive up to \$30,000. It will also be available to multi-tenant shopping center owners to apply collectively on behalf of the shopping center for up to \$250,000 with a match requirement.

Discussion ensued.

d. Major Task Force Update

Vice Chairperson Wallace reported the taskforce heard from Tom Hazinski of HVS advices state and local governments on different types of public assembly facilities. HVS noted they are looking at information sources including reviewing artificial intelligence to assist with some of the data needed to analyze major events. Commissioner Pandolfo will assist with EIR information for ticketed events. In April, the group heard from CIVITAS, lead by Commissioner Apodaca. CIVITAS submitted a proposal for services to form a Tourism Improvement District. They would provide expert advice and guidance throughout the project.
