







INTRODUCTIONS/ PRESENTATIONS:

Vice Chair Koons motions to add a presentation by the LA County Sanitation District to the agenda given that this presentation pertains to an emergency that happened after this agenda was posted. Motion carries unanimously carried by Commissioners present, with one abstention from Commissioner Watkins.

LA County Sanitation District Spokesperson, Bryan Langpap, does a presentation on the sewer spill that occurred on 12/30/21 on 212th St. due to a sewer collapse near 220th street and the 110 FWY.

In response to the Commissioners questions, Mr. Langpap states they thought they had more time to replace the pipe. He states the age and the storm that happened a couple days prior was a factor in the collapse. Alternate Villalpando inquires if there was a connection between the spill and the burn off at the refineries. Mr. Langpap states there is no connection. Vice Chair Koons asks about the timeline and if other pollutants were measured. Mr. Langpap goes over the timeline and states they monitored the water quality at various locations. Vice Chair Koons wants to know if preventative maintenance can be done in the future. Mr. Langpap states they want to fix the problem now and they are going to review their procedures so events like this won't happen again.

Discussion continues about what residents need to do that were affected by this spill and Mr. Langpap provided his information.

ACTION: Commissioner Taylor motions both items to be approved. Vice Koons seconds motion.

Motion carried with all Commissioners present except for Commissioner Watkins and Alternate Villalpando who abstained.

2. Receive and File – Article from the LA Times titled, "Poor Neighborhoods Bear the Brunt of Extreme Heat."

This item was pulled by Vice Chair Koons while approving items 1 & 3. Vice Chair Koons discusses what we can do to help the environment.

ACTION: Vice Chair Koons motions to receive and file. Commissioner Hopson seconds.

Motion carries with all Commissioners present except one abstention from Commissioner Watkins.

CONTINUED/ UNFINISHED BUSINESS:

4. Continue to discuss Work Plan for Fiscal Year 2021-2022

Staff Kulcsar discusses this item and inquires if the Commission wants to add more items to the work plan. Vice Chair Koons goes over the work plan list and requests that some items be combined. Alternate Villalpando adds additional items to the work plan. Commissioner Hopson recommends breaking down the work plan by priority. Staff Kulcsar states that staff will provide the list to each Commissioner to rank and then share the results with the commission.

NEW BUSINESS:

5. Organization: Nominate and Elect Members to Serve as Chair and Vice Chair

Commissioners want to wait to vote until the vacancies are filled in the Commission.

Commissioner Hopson motions to continue this item to the next meeting. Commissioner Taylor seconds motion. Motion carries unanimously by all Commissioners present except one abstention from Commissioner Watkins.

1. Approval of minutes for December 1, 2021

Commissioner Hopson motions to approve minutes. Commissioner Isiah-Payne seconds the motion.

Vice Chair Koons makes a friendly amendment requesting that staff correct any typos.

AYES: Koons, Isaiah-Payne, Watkins, Taylor, Hopson.

NOES: ABSTAIN: Pulido

CONTINUED/ UNFINISHED BUSINESS:

2. Nominate and Elect Members to Serve as Chair and Vice Chair

City Attorney Lona Laymon provides some background on this item. The Commissioners ask questions and discuss if this item should be continued or if nominations and elections should take place.

Isiah-Payne calls for the question that this item does not need to be continued and that the Commission should move forward in electing the Chair and Vice Chair. Chair Pulido disagrees and provides his reasons. Commissioner Isiah-Payne motions to move forward with the vote to nominate officers. Commissioner Hopson seconds the motion.

Chair Pulido makes a substitute motion that the Commission delay the election of Chair and Vice Chair until March to give the City Council time to deliberate on a pending matter that may have an impact on all Commissions and Commissioners. Vice Chair Koons seconds the motion. The substitute motion fails following a roll call vote:

AYES: Pulido, Koons NOES: Isaiah-Payne, Watkins, Taylor, Hopson, and Alternate Brillantes

The original motion which was made by Commissioner Isiah-Payne to nominate and elect members to serve as Chair and Vice Chair and Commissioner Hopson seconded the motion. Chair Pulido provides input on the original motion. Vice Chair Koons also provides additional input on the original motion. Commissioner Taylor questions why the commission can't just vote today. Commissioner Gillis-Ward joins the meeting at 7:05 PM and is given a briefing of what was discussed. A vote of the original motion is taken, and it carries with six Ayes by Commissioners Isaiah-Payne, Watkins, Taylor, Hopson, Gills-Ward, and Alternate Brillantes and two Noes by Chair Pulido and Vice Chair Koons.

Commissioner Hopson nominates Commissioner Taylor to serve as Chair and is second by Commissioner Payne. Commissioner Koons nominates Commissioner Pulido to serve as Chair. Nominations for Chair closes

A roll call vote starting with Commissioner Taylor to serve as Chair is taken and passes with the following vote:

AYES: Isaiah-Payne, Watkins, Taylor, Hopson, Gills-Ward, and Alternate Brillantes NOES: Pulido, Koons ABSTAIN: None

Commissioner Taylor wins the majority and is voted in as the new Chair for the Environmental Commission.

Nominations start for Vice Chair and Commissioner Taylor nominates Commissioner Hopson. Second nomination comes from Commissioner Pulido who nominates Commissioner Koons. Nominations for Vice Chair close.

A roll call vote starting with Commissioner Hopson to serve as Vice Chair is taken and passes with the following vote: AYES: Isaiah-Payne, Watkins, Taylor, Hopson, Gills-Ward, and Alternate Brillantes NOES: Pulido, Koons ABSTAIN: None

Commissioner Hopson wins the majority and is voted in as the new Vice Chair for the Environmental Commission

COMMISSION MEMBERS REQUESTS TO ADD ITEMS TO FUTURE AGENDAS:

Commissioner Pulido wanted an update on the work plan and wanted to explore fireworks training for safety. He also wanted to address the pollution caused by fireworks, fence line monitoring not only for the refineries but also for high pollutant places in the city (i.e., trucks that idle in the industrial places) and investigate how they might affect residents. He also wanted an update from the LA Sanitation District on the sewer line that was damaged and an update on the Dominguez Channel. He also requested an update and tour of the 157-acre site. He was also interested in beautification/tree planting.

Commissioner Hopson wanted to see a presentation from the water district on recycling efforts. Chair Taylor attended a water recycling meeting via zoom about a regional recycling program and wants to agendize this project because this may impact the Carson residents. He also requested that a presentation be made about the regional recycle program to the Commission.

Commissioner Koons recommends that a speaker come, for example, staff member Gregory MacDonald, to discuss how we can plant more trees to combat climate change and other beautification steps. He also wanted to discuss emergency plans and wanted to collaborate with the Public Safety Commission to better plan in case of an event such as the Dominguez Channel.

Commissioner Taylor wants staff to provide the work plan list before the next meeting.

COMMISSION MEMBERS ORAL COMMUNICATION:

Commissioner Hopson congratulates Chair Taylor. Commissioner Koons invited Commissioners to a meeting hosted by AB617 in which he is a member of. Alternate Brillantes wants the agenda to be sent to them before the meeting. Commissioner Gillis-Ward requests that they get the minutes shortly after the meeting. Commissioner Pulido suggests the minutes get sent two weeks after the meeting. Staff Kulcsar states that staff will discuss and determine if this request can be accomplished and report back. Commissioner Pulido congratulates Chair Taylor and reminds the commission that there is a map for redistricting and there needs to be more public input on the re-districting.

STAFF ORAL COMMUNICATIONS:

Director Eliza Jane suggests a presentation from the coordinator from the watershed in which the City is part of. Commissioners are open to the presentation and it will be arranged in March or April depending on the speaker's availability. Eliza Jane also informs the Commissioners that the City, with the help of West Basin, is looking at drought tolerant designs around City Hall and possibly the Community Center. Eliza Jane also shares that Reata and her are working on getting EV chargers. Lona suggests adding this information to the agenda to give an update to the commission.

ADJOURNMENT:

There being no further discussion, on a motion by Vice Chair Hopson and seconded by Commissioner Koons, the meeting was adjourned at 8:14 p.m. to the next regular meeting to be held on the 2nd day of March 2022, at the hour of 6:30 p.m., via zoom.

Agenda Requirements

- A written agenda must be prepared for each meeting of the City Council.
- The agenda must include all matters to be transacted or discussed.
- No action may be taken if an item is not on the agenda (unless it is a qualified emergency item).
- Each item on the agenda must include a brief description, sufficient to inform the public of the nature of each item of business, which allows the public to determine whether to participate.



Regular v. Special Meetings; Notice

- Regular Meetings: Written agenda must be prepared and posted 72 hours prior to each regular or adjourned regular meeting of each legislative body.
- Special meetings: Must give 24 hour notice that serves just like an agenda.
 - Notably, public comment on special meetings is limited only to items actually on the agenda. There's no "general" public comment period.

Agenda Requirements: Exceptions

- No discussion of any item not on agenda
- ... Except:
- Brief responses.
- Statements or questions.
- Questions for clarification.
- Reference to staff or other resources for factual information.
- Request staff to report at a subsequent meeting.



Summary—Stay on Point!

- *Generally*, all matters to be transacted or discussed must be agendized.
- Must include reasonable period of time for public comment before or during consideration of each item.
- Special "Urgency Exception": To add a new matter body must find: (1) matter arose after agenda was posted, and (2) there must be a 2/3 vote of members present at the meeting-but, a unanimous vote if less than 2/3rds are present!
