
Fair Process Laws

Principle: As a decision-maker, the public expects you to be impartial and avoid favoritism



Fair Process Laws

- Due process requirements and rules against bias
- Incompatible office prohibitions
- Due process requires fairness in decision-making: Must hear evidence and make decisions or recommendations based on evidence



How Does This Apply to This Commission?

- COMMISSION IS ASSIGNED TO:
- "Undertake investigation and studies, and to hold hearings concerning the pollution of the City's environment..."
- "Consult and advise with public officials and agencies on the local, State and Federal level, with members of the industrial, civic, educational and professional communities, either individually or in concert, towards the goal of accomplishment and execution of the environmental plans, programs and policies approved by the City Council."
- "Coordinate enforcement by, and cooperative efforts between, other concerned governmental agencies, private firms and organizations and the several departments of the City."
- (Carson Municipal Code 2753.)

<u>Due Process = Fair Process</u>

City of Fairfield v. Superior Court (1975)

"A councilman has a right to state his views on matters of community policy, and his vote may not be impeached because he does so."

<versus>

- Clark v. City of Hermosa Beach (1996)
- Nasha v. City of Los Angeles (2004)

Fair Process Laws, Cont.

DO NOT ADVERTISE A "BIASED" VIEWPOINT!

- Extra-meeting contacts can give appearance of impropriety.
- Accommodation necessary since commissioners appointed because of knowledge and experience with community.
- Site inspection okay.
- Avoid initiation of contact.
- If you are contacted, be polite, avoid stating viewpoint.
- At meeting (especially any hearing), enter into record any information which will be relevant to discussion (e.g., site visit).
