
#### Q2 Do you rent or own your home?



#### Q4 Which group do you represent? Please select all that apply.





# Q5 Choose up to three (3) of the most critical community facilities needs in Carson.



# Q6 Choose up to three (3) of the most critical community services needs in Carson.











# Q10 Choose up to three (3) of the most critical housing services needs in Carson.





# Q11 Choose up to three (3) of the most critical infrastructure needs in Carson.










