NEW BUSINESS:

2. Update on Existing and New Building Reach Codes and Building Performance Standards

Walker Wells from Raimi & Associates presented on building electrification and performance standards to the commissioners, sharing information and encouraging discussion to inform the potential adoption of specific measures by year-end or early next year.

3. Oral Report by the Energy and Sustainability Officer

Staff member Kulcsar provided verbal updates on recent refinery questions. Staff member Kulcsar also indicated that staff had contacted representatives from TRAA and were awaiting a response. Handouts summarizing the Earth Day survey results were distributed and reviewed with the Commissioners. Regarding the electric vehicle charging projects, staff shared that nearly all electric vehicle charging stations are operational, with the exception of two sites.

COMMISSION MEMBERS ORAL COMMUNICATION:

Vice Chair Hopson congratulated the Chair for doing a great job at the last council meeting. Commissioner Koons wanted to know if there was an emergency plan in place for the City in light of the refineries. He also inquired about the recent testing of the alarm system at a local refinery. Staff stated that they would reach out to Public Safety staff to determine what documents were available to share. Commissioner Swazyer congratulated the commission on the Earth Day Event and also asked if the commission had a list of objectives they wanted to accomplish. Chair Taylor stated that the commission has a priority list of activities and accomplishments. Alternate Commissioner Ford suggested that the City could use drones instead of fireworks for a show that could be funded through grants and would benefit the environment. Chair Taylor thanked everyone who attended Earth Day and the Council meeting.

STAFF ORAL COMMUNICATIONS:

Staff member Kulcsar announced that staff would be tabling at a non-City sponsor health fair scheduled for May 10, 2025, at the Dominguez Community Center. Judy Baladi mentioned that the City Attorney's Office continues to work on updating the municipal code language to allow greater flexibility for the Commission in scheduling formal meetings.

Without further discussion, Chair Taylor made a motion to adjourn the meeting, which Commissioner Swayzer seconded. The meeting adjourned at 7:45 pm. The next regular meeting is scheduled for June 4, 2025, at 6:30 p.m. in City Hall.
