PUBLIC REVIEW OF THE 2021 DRAFT ANNUAL ACTION PLAN

NOTICE IS HEREBY GIVEN that the City of Carson has prepared the Community Development Block Grant Program 2021 draft Annual Action Plan. The publication of this notice establishes the beginning of the minimum 30-day public review period required under Federal Regulation 24 CFR 91.105(b)(2). This public review is part of the City of Carson's Citizen Participation Plan, which is intended to facilitate public comment on the 2021 Annual Action Plan document. A copy of the one-year budget portion of the draft Annual Action Plan is attached for your review. The public review and written comment period begins Tuesday, April 6, 2021, and runs through Monday, May 10, 2021.

The Annual Action Plan is a yearly program document detailing community development priorities and the immediate plans of the City to address those priorities. The City of Carson is required to submit an Annual Action Plan to the U. S. Department of Housing and Urban Development (HUD) in order to participate in a variety of grant programs. These HUD programs could include the Community Development Block Grant (CDBG), HOME Investment Partnership (HOME), and Emergency Solutions Grant (ESG) programs.
