



NOTICE OF PUBLIC HEARING ADOPTING INTERIM URGENCY ORDINANCE NO. 26-2604U

NOTICE IS HEREBY GIVEN that the City Council of the City of Carson, California will conduct a Public Hearing at which time you may be present and be heard to consider extending a temporary moratorium on the establishment or expansion of drive-through restaurants within city limits during the pendency of the city's review and adoption of permanent zoning regulations for such uses for an additional ten months and fifteen days, and declaring the urgency thereof. The proposed action would extend the existing temporary moratorium for twelve (12) months from its currently scheduled date of expiration, thereby extending it until March 6, 2027.
