NOTICE IS HEREBY GIVEN that the City Council of the City of Carson, California will conduct a Public Hearing at which time you may be present and be heard to consider Ordinance No. 25-2514 approving various Text Amendments to the City's Zoning Ordinance related to Community Development Director approval authority and requirements and City Council review procedures, and Urgency Ordinance No. 25-2515U making a finding of urgency pursuant to City Charter Section 313F, and approving various amendments to the text of the City's Zoning Ordinance related to Community Development Director approval authority and requirements and City Council review procedures. The City Council will also consider that the adoption of these ordinances is exempt from review under the California Environmental Quality Act (CEQA) under the "common sense" exemption in CEQA Guidelines Section 15061(b)(3) because it can be seen with certainty that there is no possibility that the adoption of this ordinance may have a significant effect on the environment.
