### ANNUAL ACTION PLAN PROPOSED ALLOCATION OF COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS FOR FISCAL YEAR 2021-2022

The City Council of the City of Carson will conduct a public hearing concerning the allocation of Community Development Block Grant (CDBG) funds for the upcoming 2021-2022 fiscal year, otherwise known as the 2021 program year. The CDBG program is proposing the Annual Action Plan and the allocation of funds for this coming year's 2021-2022 CDBG budget. This hearing will include presentations by public service organizations requesting funding for this coming program year. In keeping with our citizen participation guidelines, staff is requesting that Council take public testimony at this hearing and review the suggested budget submitted by staff. After due consideration and any amendments, staff requests that Council approve the CDBG budget for fiscal year 2021-2022 if Council believes it is appropriate to do so. The estimated amount of CDBG entitlement funds available for this coming program year is \$782,188.

A copy of the proposed 2021-2022 fiscal year CDBG budget and support documentation will be on file for public review in the Office of the City Clerk at City Hall, and will also be available on the City's website, <http://ci.carson.ca.us> . A copy of the proposal may also be purchased. Additional information may be obtained from the staff of the Community Development Department in City Hall, Monday through Thursday, 7:00 A. M. to 6:00 P. M., or by telephoning (310) 830-7600, extension 1319. For your convenience, a full copy of the staff report with exhibits will be available at the Community Development Department no later than the afternoon of Thursday, April 15, 2021, for review and/or purchase.

Please note that in the event of a court challenge to the approval or denial of this proposal, testimony may be limited to issues raised at the public hearing or addressed in correspondence delivered to the City Council through the City Clerk's Office prior to the public hearing.
