NOTICE IS HEREBY GIVEN that the City Council of the City of Carson, California will conduct a Public Hearing at which time you may be present and be heard to consider Introduction and First Reading of an uncodified Ordinance adopting Mitigated Negative Declaration and Mitigation Monitoring Reporting Program, (1) adopting Mitigated Negative Declaration and Mitigation Monitoring And Reporting Program with respect to approval of Development Agreement No. 32-22; and (2) approving Development Agreement No. 32-22 between the city of Carson and Avocet Energy Storage, LLC for a proposed battery energy storage system (BESS) project at **23320 Alameda Street (APN 7315-020-022)**. Pursuant to Section 15070 of the California Environmental Quality Act (CEQA) a Mitigated Negative Declaration with Errata has been prepared and will be considered by City Council.
