11. PUBLIC HEARING

A) Conditional Use Permit No. 858-11

Applicant's Request:

The applicant, Sears Holdings Corporation, is requesting to facilitate exterior improvements to a Sears Automotive Center on a site located in the CR-D (Commercial, Regional-Design Overlay Review) zoning district. The subject property is located at 20420 South Avalon Boulevard.

<u>Staff Report and Recommendation</u>:

Associate Planner Gonzalez presented staff report and the recommendation to WAIVE further reading and ADOPT Resolution No. 11-2388, entitled, "A Resolution of the Planning Commission of the city of Carson approving Conditional Use Permit No. 858-11 for an existing vehicle service and repair use (Sears Automobile Service Center) located at 20420 South Avalon Boulevard." He amended the resolution by adding "and the project complies with Carson Municipal Code Section No. 9138.2" to Section 3.

Chairman Faletogo opened the public hearing.

Sean Teagve, applicant's representative, noted his concurrence with the conditions of approval.

Chairman Faletogo closed the public hearing.

Planning Commission Decision:

Commissioner Diaz moved, seconded by Commissioner Gordon, to approve the applicant's request; added "and the project complies with Carson Municipal Code Section No. 9138.2" to Section 3F; and moved to adopt Resolution No. 11-2388. Motion carried, 8-0 (absent Commissioner Schaefer).

12. NEW BUSINESS DISCUSSION

A) Workshop to discuss Zoning Ordinance

Applicant's Request:

The applicant, city of Carson, is requesting the Planning Commission discuss the organization and layout of the Zoning Ordinance and possible improvements to provide for consistency and proper procedures in implementation for properties citywide.

Staff Report and Recommendation:

Associate Planner Signo presented staff report and the recommendation for the Planning Commission to CONSIDER and DISCUSS the information provided for in this workshop.

Vice-Chairman Park agreed that some of the ordinances need to be updated, especially with regard to the second unit ordinance. He noted his opposition to waiving ordinance requirements.

Commissioner Saenz stated that public health, welfare and safety should never be disregarded when making decisions, highlighting his concerns with the problems with drainage in the Sea County community and the building of a house on a small parcel in that community.

Chairman Faletogo agreed that new guidelines should be put in place in order to move forward and help to phase out legal nonconformities.

Senior Planner Signo explained that staff will be incrementally bringing proposed changes before the Commission for consideration.

Chairman Faletogo thanked Senior Planner Signo for his report.

Commissioner Verrett moved, seconded by Chairman Faletogo, to direct staff to continue to do further analysis on issues needing refined in the Zoning Ordinance to provide for consistency and proper procedures in implementation.
