# Applicant's Request:

The applicant, Dignity Health Sports Park, is requesting to confirm administrative approval for the refurbishment of two electronic marquee signs. The signs are located at 21710 Recreation Road and 431 Albertoni Street.

# Staff Report and Recommendation:

Associate Planner Bhatia presented staff report and the recommendation to ADOPT Resolution No. 20-2701, entitled, "A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF CARSON CONFIRMING ADMINISTRATIVE APPROVAL AUTHORITY FOR THE REFURBISHMENT OF TWO ELECTRONIC MARQUEE SIGNS AT 21710 RECREATION ROAD AND 431 ALBERTONI STREET." Staff highlighted amendments to the resolution in Section 2 (ii), 2(v) & 2 (vi) and Section 3.

Chair Pimentel opened the public hearing.

Katie Padolfo, applicant's representative, explained that the signs need to have modernized technology and noted her concurrence with the conditions of approval.

There being no further input, Chair Pimentel closed the public hearing.
