I. Introduction

Project Description

The proposal was a conditional use permit (CUP) for an existing second dwelling within the RS (Residential, Single Family) zone district.

Conditional Use Permit (CUP) No. 931-13, would have legalized a second dwelling unit located at 2624 E. Madison Street.

II. Background

History of Property

The existing main dwelling and a one-car garage were built in 1923. The rear second dwelling unit consists of approximately 475 square feet and appears to have been constructed in 1925.

On October 22, 2013, and on February 25, 2014 the Planning Commission continued Conditional Use Permit No. 931-13 to allow the owner more time to obtain contractor estimates to repair the second dwelling to Carson's building code requirements or seek demolition of the dwelling.

On April 1, 2014, staff received a signed letter from the applicant in Spanish indicating that the second dwelling unit was demolished. Conditional Use Permit No. 931-13 application is therefore withdrawn and staff will close the subject file.
