Vice Chair closed the Public Hearing.

Commissioner Guerra was curious about the 52 loading docks, he asked if that is accurate. Applicant Yemi Alade confirm that between the 2 building there's a total of 52 loading docks.

Assistant City Attorney asked that Public Hearing be opened if Commissioner Guerra wants to ask questions.

Vice Chair re-opened Public Hearing for Commissioner Guerra to ask guestions to applicant.

Commissioner Guerra ask the applicant if he anticipates high queue warehouse type of use?

Applicant Yemi Alade stated that they don't anticipate that type of use.

Applicant Charlene So, Urban Cross, stated that they don't have plans for that type of use and if needed, they will work with the City to meet requirements.

Commissioner Hernandez asked the applicant how many workers will be working on the project and how many in percentage will be union?

Applicant Yemi Alade did not have a number of workers at this time. They have executed contracts with LiUNA, CREEDLA and Southwest Carpenters Union but they don't have percentages at this time.

Division Secretary M. Gonzalez mentioned there's a comment letter received.

Associate Planner Whiting read comment letter into the record from Barry Waite, President, Carson Chamber of Commerce. Letter supports this project.

Public Hearing was closed.

Commissioners Comments:

Commissioner Thomas visited the site, she likes to see the site before making a decision, she likes to see the environment and what's involve any construction site. The area it's a blighted area by Broadway & Alondra. As she traveled from Broadway to Main, crossing Main a property that has been renovated/rebuilt looks very nice. Liked the project's rendering. Project looks really good. It's not a residential area. It's an industrial area and she is in favor of the project.

Commissioner Diaz stated that he reviewed staff report and did not see a Development Agreement and ask if this project had a Development Agreement?

Community Development Director responded that they did not have a Development Agreement for this project. Doesn't provide any community benefits other than what's on the conditions of approval. Project is consistent with the zoning and general plan.

Commissioner Guerra really likes the project and appreciates that they are using union labor that are extremely qualified and local. That saves on vehicle miles travel and it helps our environment and he appreciates them doing this.

Commissioner Hernandez likes project's esthetics on these buildings looks excellent. Mentioned if Tommy Saavae is involvement on this project and he knows it'll be an outstanding project.

Vice Chair Palmer made (1st) motion to approve staff's recommendation, including CEQA findings. Commissioner Thomas (2nd) motion to approve. Motion passed. Vote 8-0.

8. PLANNING MANAGERS REPORT

Community Development Director introduced Laura Gonzalez. She was promoted to Planning Secretary. She will be taken over next meeting. Congratulated her, she has been with the City of over a year. She is very dependable employee and very lucky to have her. Next item, staff would like to request the commission to hold a Special Meeting for November 21st, to consider the Imperial Avalon Specific Plan and EIR.

Assistant City Attorney Jones explained that to call the special meeting can be done by the Chair on his own or by the majority of the commission. The Chair can simply announce his intent to call the special meeting. The call of the special meeting is not be complete until it's followed-up with a written notice of a special meeting, which will function as the meeting agenda, which will provide/state the item to be consider. No other item will be considered other than the item specified in the notice. That will be the certification of the EIR, for the Imperial Avalon Specific Plan project, which includes the Design Overlay Review, the Vesting Tentative Tract Map, as well as a recommendation of approval of a Specific Plan, General Plan Amendment, Zone Change and a Development Agreement. Vice Chair Palmer can announce his intent to call the special meeting. No vote is needed. He can follow-up with a written notice of special meeting that will be delivered to each of the commissioner.

Vice Chair Palmer called the Special Meeting of the Planning Commission on Monday, November 21, at 6:30 p.m. to discuss the EIR certification for project that Ben articulated. Via Zoom. Agenda to follow.

Commissioner Thomas asked why the meeting is on Monday, November 21 and not November 22nd.

Community Development Director Naaseh, for timing purposes, to meet the schedule deadline for the project. Assistant City Attorney Jones added for noticing the public hearing and things of that nature.

Hope everybody voted.
