SUBJECT: US POSTAL SERVICE (CUP 1102-2020) TRIP GENERATION ASSESSMENT

Dear Mr. Blake Kelley:

Urban Crossroads, Inc. is pleased to provide the following Trip Generation Assessment for US Postal Service use (**Project**) which is located at 24760 S. Main Street in the City of Carson. The purpose of this work effort is to identify the current trip generation for the Project in comparison to the previous 3rd party logistics (3PL) tenant.

PROJECT DESCRIPTION

PREVIOUS USE: HIGH-THROUGHPUT LOGISTICS FACILITY

The site was formerly occupied by 24/7 Trucking, a 3PL high-throughput logistics facility. The building had 50 dock doors with loading docks on the east side and south side of the building and additional trailer parking to the east of the building.

EXISTING USE: POSTAL-SORTING FACILITY

The Project consists of a single, concrete tilt-up building with 231,008 square feet of warehousing (postal-sorting facility) use which is currently occupied by the United States Postal Service on a 10.08-acre site. The Project has two points of access onto S. Main Street.

The facility currently operates 24-hours per day, 7 days a week, but has less traffic on the weekends and with higher levels of traffic between 5 AM and 8 PM during the weekdays. There is currently a total of 310 employees (3 shifts), where on average, there are approximately 40 employees that start at 4 AM, approximately 80 employees that start at 10 AM, and approximately 80 employees that start at 8 PM. All dock stalls on the existing building are utilized, including the eastern dock stalls 32-48 and have trailers parked in the yard. Heavy trucks in and out of the facility occur all day long, however, the peak activity occurs between 12 AM and 8 AM. There are currently 360 trucks per day with a turnaround time of 30 minutes. The warehouse building is 231,008 square feet.

The Project is proposing to remain operating 24-hours per day, 7 days a week, however, new operations are proposed for the employees and trucks. There are 3 tours (or shifts) proposed for employees:

- Tour 1 is from 10 PM to 7 AM and includes 108 employees
- Tour 2 is from 7 AM to 3 PM and includes 152 employees
- Tour 3 is from 3 PM to 10 PM and includes 169 employees
- **Total employees are 429 or an increase of 119 employees (38% increase)**

Trucks at the site are anticipated to reduce to 173 trucks per day from 360 trucks (52% reduction) in conjunction a faster truck turn around of 15-20 minutes per truck (as opposed to the currently 30 minutes per truck).

TRIP GENERATION

PREVIOUS USE: HIGH-THROUGHPUT LOGISTICS FACILITY

A 3PL high-throughput logistics facility use does not have trip generation rates readily available in the Institute of Transportation Engineers (ITE) Trip Generation Manual (10th Edition, 2017). As such, traffic counts collected at 700 Eckhoff Street in Orange, California on November 10 and 12, 2020 and 2550 E. 28th Street in Vernon, California on November 24 and 25, 2020 were utilized to develop trip generation rates for this specific use. A summary of the count data collected over the 2 days is provided in Attachment A for 700 Eckhoff Street. Table A-1 in Attachment A provides a detailed summary of the counts collected on each day at each driveway location. Table A-2 in Attachment A provides the total trip generation for the site for each day and also shows the average 2-day trip generation. The average 2-day trip generation was then divided by the total square footage (43,454 square feet) to develop the trip generation rates for the 700 Eckhoff Street site (see Attachment A, Table A-3).

Similarly, a summary of the count data collected over the 2 days is provided in Attachment B for 2550 E. 28th Street. Table B-1 in Attachment B provides a detailed summary of the counts collected on each day at each driveway location. Table B-2 in Attachment B provides the total trip generation for the site for each day and also shows the average 2-day trip generation. The average 2-day trip generation was then divided by the total square footage (20,586 square feet) to develop the trip generation rates for the 2550 E. 28th Street site (see Attachment B, Table B-3).

Table 1 presents the resulting trip generation rates calculated for the High-Throughput Logistics Facility use based on an average of data collected at the 2 sites located at 700 Eckhoff Street and 2550 E. 28th Street.

Based on the trip generation rates shown in Table 1, the trip generation for the previous 24/Trucking tenant has been calculated and is shown in Table 2. As shown in Table 2, the previous use generated 2,520 two-way daily trips with 161 AM peak hour trips and 162 PM peak hour trips. Trip generation is also provided in passenger car equivalent (PCE). The previous use generated 4,695 two-way PCE daily trips with 241 PCE AM peak hour trips and 322 PCE PM peak hour trips.

EXISTING USE: POSTAL-SORTING FACILITY

The existing trip generation for the Project is based on empirical data. The site located at 24760 S. Main Street was surveyed over two-consecutive days on December 8th and 9th, 2020. The two-day count surveys were used to develop an average trip generation for the existing facility. A summary of the count data collected over the two-days is provided in Attachment C. Table C-1 in Attachment C provides a detailed summary of the counts collected on each day at each driveway location. Table C-2 in Attachment C provides the total trip generation for the site for each day and also shows the average two-day trip generation.

Table 3 presents a summary of the average trip generation calculated for the existing facility based on an average of data collected at the site over two days. It should be noted that the peak hour data reflected on Table 3 are the peak hours of the generator, which were 1-2 AM and either 7-8 PM or 7:45-8:45 PM. As shown in Table 3, the Project currently generates 1,756 two-way daily trips with 121 AM peak hour trips and 163 PM peak hour trips (peak hour of the generator). The Project generates 3,202 two-way PCE daily trips with 187 PCE AM peak hour trips and 215 PCE PM peak hour trips.

The peak season typically occurs over a period of 6-weeks between Thanksgiving and Christmas. Based on discussions with the Applicant, the trip generation data used for the purposes of this assessment are conservative as the counts were collected in early December during the peak season.

Table 4 presents a summary of the average trip generation for the proposed operations of the facility by increasing the passenger car traffic in Table 3 by 38% and decreasing the truck traffic in Table 3 by 52%. These percentages are based on the anticipated net increase in employees for the proposed operation and the net reduction to daily truck trips. As such, Table 4 summarizes the proposed operations of the facility. As shown in Table 4, the Project is anticipated to generate 1,758 two-way daily trips with 137 AM peak hour trips and 201 PM peak hour trips (peak hour of the generator). The Project is anticipated to generate 2,452 two-way PCE daily trips with 169 PCE AM peak hour trips and 226 PCE PM peak hour trips.

TRIP GENERATION COMPARISON

Table 5 shows a comparison of the previous high-throughput logistics facility versus the proposed postal-sorting facility. As shown on Table 5, the proposed Project generates 2,243 fewer two-way PCE trips per day with 72 fewer PCE AM peak hour and 96 fewer PCE PM peak hour trips as compared to the high-throughput logistics facility.

TRUCK ROUTE

Exhibit 1 shows the agreed upon truck route for the USPS facility between the site and the I-110 Freeway. The identified route utilizes Sepulveda Boulevard, Figueroa Street, Lomita Boulevard and Main Street. It should be noted that field observations on December 8th and 9th, 2020 (when traffic counts were collected), indicated the identified truck route was not being utilized based on the mid-day queues observed along Main Street. As such, enforcement of the agreed upon route as shown on Exhibit 1 is necessary. Observed queues of trucks along Main Street was a maximum of 20 trucks.


