You may be eligible for a senior discount on the rates for solid waste collection services! See below for qualifications and how to apply.

Qualifications:

- Must be 62 years of age or older (as of July 1, 2021).
- Must own and reside on the property that will receive the discount. You will need to provide proof of ownership and Carson residency.

Other Information:

- Application valid for one year only - you must reapply each year.
- In multi-dwelling buildings, discount only applies to the homeowner's dwelling unit.
- Discount only applies to customers with residential cart service.
- Discount does not apply to mobile homes.

If your application is received after this date, it will not be processed and you will have to wait until next year to complete a new application.
