GENERAL RULES / REGULATIONS:

FIELD, GOAL and GAME BALL SIZE / DIMENSIONS:

Ball: Rookie Division will use a #3 size soccer ball

Field: Rookie 60 yards x 40 yards (8 on 8)

Goal size: Rookie 5' x 10' - A restraining line shall be placed completely around the outside of the field at least three yards from the sidelines and end lines for all patrons and players / coaches to stand / sit behind to avoid injury while game is in play.

START OF EACH GAME: A team not having six players on the field ready to play. Game time is the scheduled game time or time designated by the referee. **EXCEPTION:** Rookie Divisions: Staff and/or coaches will adjust the number of players on each team, if necessary to play a game.

PERIODS OF PLAY: Rookie Division games shall be two twenty-minute halves, running time. There shall be a five-minute rest period between the first and second halves.

Substitution: a ten-minute mark will be used in Rookie Division after which time, players may be substituted when there is a stoppage of play. Coaches are required to allow equal participation.

A pair of protective shin guards must be worn by all players at all times, during play.

A player shall not wear any type of jewelry while participating in a game.

COACHES RESPONSIBILITIES: The head coach is responsible for the conduct and behavior of all players, assistant coaches, and parents from their designated teams.
